We may process special categories of personal information in the following circumstances:

• We will use information about your physical or mental health, or disability status to administer discounts and exemptions.

Purpose Collected

Section 1 of the Local Government Finance Act 1992 gives the Billing Authority the power to levy and collect Council Tax payable in respect of dwellings situated in its area.

We will use your personal information in the processing of Council Tax to ensure Council Tax charges are correct, ensure you receive any reductions or support that you are entitled to and in issuing Council Tax Bills. We will also use your information to collect and receipt payment and to action nonpayment, including the issue of recovery documents and notices, referring cases to courts as deemed necessary and appointing enforcement agencies to recover unpaid Council Tax.

We will use your personal information to process appeals received against Council Tax liabilities including attendance at tribunals as necessary.

We pass information on to the Valuation Office Agency to enable them to maintain the Valuation List.

We will use your information for the prevention and detection of fraud under Digital Economy Act 2017 (Part 5), to ensure the electoral register is accurately maintained in accordance with Section 9A of the Representation of the People Act, to assist with debt management and the collection of money owing to the Borough Council such as rent or other sundry debts and to identify empty homes across the borough in accordance with Local Government Finance Act 1992

We will also share your data with the <u>Office for National Statistics</u> (ONS) to help with the production of statistics related to the economy, population and society and to help with the Census.

Details of the information we will share and how it will be used can be viewed on the <u>Office</u> <u>for National Statistics</u> (ONS) website.

Legal Purpose

We will only use your personal information when the law allows us to. Most commonly we will use your personal information under **Legal Obligation** as the processing is necessary for us to comply with the law namely:

- Council Tax (Administration and Enforcement) Regulations 1992 (Business rates Only)Local Government Finance Act 1992
- The Council Tax (Discount Disregards) Order 1992
- The Council Tax (Exempt Dwellings) Order 1992
- Local Government Finance Act 2012
- Localism Act 2011
- Tribunals Courts and Enforcement Act 2007 Local Government Act 2003

The list is not intended to be exhaustive

We also process your personal information for us to perform our **Public Task** as the processing is necessary for our official functions, and the task or function has a clear basis in law, namely administering Council Tax payments in accordance with the above legislation

Where needed, for the performance of a task carried out in the public interest or in the exercise of official authority vested in us (Article 6(1)(e) UK GDPR and section 8(c) Data Protection Act 2018) in service to section 45A Statistics and Registration Service Act 2007 (SRSA 2007) – ONS data sharing

Where processing is necessary for reasons of public interest (Article 9(2)(g) UK GDPR and section 10(3) & Schedule 1, para.6(2)(a) Data Protection Act 2018) justified by section 45A SRSA 2007 – ONS data sharing

Processing of data relating to criminal convictions and offences (Article 10 UK GDPR and section 10(5) & Schedule 1, para.6(2)(a) of the Data protection Act 2018) justified by section 45A SRSA 200 – ONS data sharing

Some of your information may also be used:

- to safeguard adults, and children under the Children's Act 1989
- to detect and prevent issues relating to environmental health under the Environmental Protection Act 1990, Part III, section 79
- for the purpose of consumer protection under the Consumer Rights Act 2015

Third Parties we might share information with

We will share your personal information with third parties where required by law or where it is necessary to administer your Council Tax account. In circumstances where sharing your information is not required by law or is necessary to provide administration, we will collect your consent that the information can be shared.

Examples of the organisations we may need to share information with are below, this list is not exhaustive:

Valuation Office Agency - the Council may share your details in order to obtain a Council Tax band for your property.

PSL – The Council's postal distributor PSL will have access to your personal information for the purpose of distributing Council Tax bills and Reminder Notices and other correspondence.

I Mail - The Council's postal distributor PSL will have access to your personal information for the purpose of distributing Council Tax bills and Reminder Notices and other correspondence.

Civica - The Council's IT provider Civica may have to access the document imaging system on occasions where there is a fault

Cseries – The Council's Financial System Provider Cseries may have access to your personal information on occasions where there is a fault

Bottom-line - The Council's Financial System Provider Bottom Line may have access to your personal information on occasions where there is a fault

Bacs –financial information for the administration of Council Tax

How secure is my information with third-party service providers?

All our third-party service providers are required to take appropriate security measures to protect your personal information in line with the GDPR regulations. Our third-party service providers are not permitted to use your personal data for their own purposes. We only permit them to process your personal data for specified purposes and in accordance with our instructions.
