Purpose Collected

We collect your information to ensure we meet our legal requirements and/or as part of the administration of services we provide to you or services we provide to you on behalf of other organisations.

We will use your information to process your financial transactions with Tamworth Borough Council or where the council is acting on behalf of other organisations or government bodies, such as the Department for Works and Pensions.

We will use it to contact you regarding your enquiries, compliments or complaints, contact you regarding services you access and to keep a record of your relationship with us

Occasionally, with your consent, we will use your information to undertake customer research to help us understand how we can improve our services or information, tell you about changes in our services or new services, events, and offers

We may use the information you provide to us for the prevention and detection of crime. We may also share this information with other bodies that are responsible for auditing or administering public funds including the Audit Commission, the Department for Work and Pensions, other local authorities, HM Revenue and Customers and the Police.

We would also use your information to assist the Council in responding to emergencies or major accidents.

The Council's website does not automatically capture or store personal information, other than logging the user's IP Address or the location of your computer or network on the Internet, for systems administration and troubleshooting purposes. If you are connected to the Internet, you have an IP address.

Legal Purpose

Customer Services acts as a data processor for all departments within Tamworth Borough Council and act as a data processor for external organisations, such as Staffordshire County Council.

We will only use your personal information when the law allows us to as part of our **Legal Obligation**, as part of a **Contract** we have with you, as part of our **Public Task** or with your **Consent** - as outlined in the Fair Process Notice for the service(s) you are accessing. #

We will only process your information for customer research, marketing and profiling with your **Consent**. You can remove your consent at any time by contacting Tamworth Borough Council.

Third Parties we might share information with

We will share your personal information with internal departments and external organisations and other service providers who are providing a service to you or as part of responding to a complaint, complement or enquiry. We will only provide the information that is necessary.

We will share your information with third parties:

- to comply with a legal obligation
- where permitted under the Data Protection Act 1998
- where the disclosure is necessary for the purposes of the prevention and/or detection of crime
- where it is necessary to allow a third party working for or on behalf of the Council

Third-Parties Service Providers – Which third parties process my personal information?

Third-Party Service Providers are companies who process your information on Tamworth Borough Council's behalf.

The following third-parties process personal information about you for the following purposes:

AIMS – The Council's IT provider AIMS may have to access your personal information on occasions where there is a fault.

Efins – The Council's IT provider Efins may have to access to your personal information on occasions where there is a fault.

LAGAN – The Council's IT provider LAGAN may have to access to your personal information on occasions where there is a fault.

Blackboard – The Council's IT provider Blackboard may have to access to your personal information on occasions where there is a fault.

Parker – The Council's IT provider Parker may have to access to your personal information on occasions where there is a fault.

How secure is my information with third-party service providers?

All our third-party service providers are required to take appropriate security measures to protect your personal information in line with the GDPR regulations. Our third-party service providers are not permitted to use your personal data for their own purposes. We only permit them to process your personal data for specified purposes and in accordance with our instructions.

Your personal data is processed (including storage) within the European Economic Area only.
