Summary Accounts 2021/22

The Cost of Council Services for 2021/22

The Comprehensive Income and Expenditure Account below details the cost of running Council Services between April 2021 and March 2022, where the money came from to finance those costs along with the surplus or deficit at the year end.

Tamworth Borough Council budgeted to use £0.3m from General Fund balances in 2021/22. The year-end position showed an increase in balances of £1.2m to £9.2m.

The improvement in the Council's estimated financial position arose mainly from additional income from Government Grants, commercial property rents, interest on investments, unspent reserves and savings in Joint Waste arrangement costs.

Housing Revenue Account

The overall revenue financial position relating to council housing shows an increase in balances for the year of £0.1m from £5.6m to £5.7m - to be carried forward to 2022/23.

This equates to an underspend of £0.4m when compared to the approved budget for the year, mainly due to additional income from service charges, lower housing repairs contract costs together with savings in contingency budgets.
